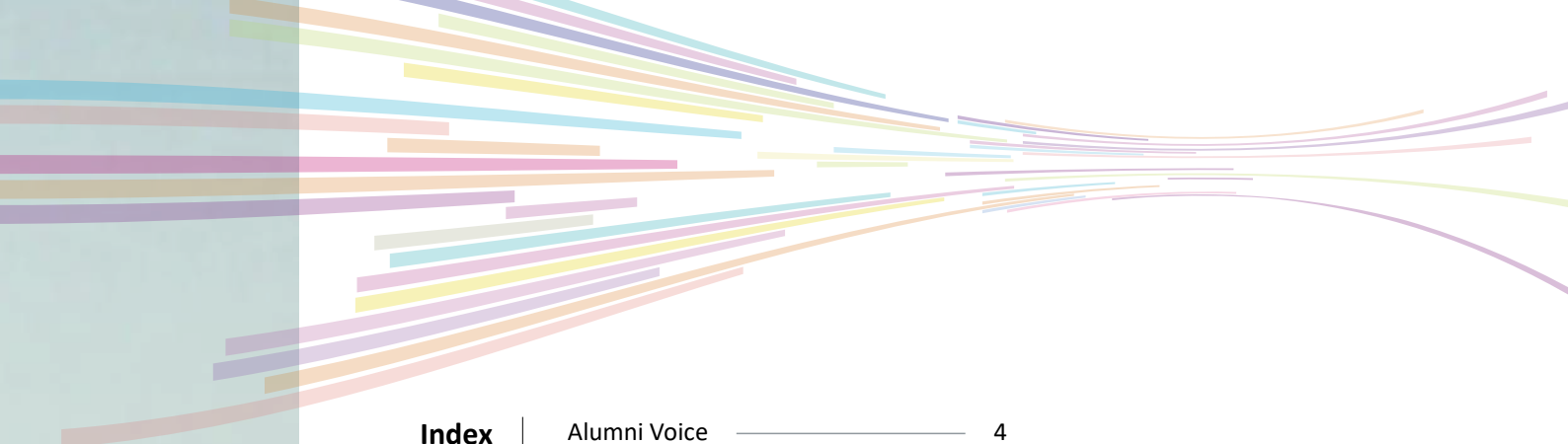


Where the World Cooperates

Living in Urasa, and studying at IUJ in particular, might be the most memorable two years in my life. Not only did I have a chance to study from the prominent lecturers in the IRP Program, but I was also able to have countryside experiences and build friendships with the local people.

Urasa and its surrounding mountains offer the *Sakura* beauty of Spring, the romantic 3 colors Koyo (紅葉) of Autumn, and the magnificent land of snow (*Yukiguni*) in Winter. For potential IUJ students, you will regret it if you don't take some time to experience these wonders. I made friends with a local farmer, who eventually became a business partner, and we are still friends today.

I was lucky enough to be a recipient of the Niigata International Association (NIA) Scholarship. However, I also needed to take on part-time jobs to cover my living costs. Nonetheless, I eventually realized that this was a blessing in disguise!

During my time at IUJ, I participated in a variety of extracurricular and off-campus programs. These included being a guest teacher at nearby schools, serving as a member of the Graduate Students Organization (GSO), introducing my traditional culture to others, and assisting in local festivals. Not only did these activities contribute to my financial stability, but also enabled me to balance my academic *and* non-academic life. This helped me to practice the Japanese language and learn about Japanese culture, which has proven useful for my professional career.

IUJ's Student Services Office supports every student in their search for fulfilling employment : from getting an internship to landing their dream job. IUJ helped me to find a very well paid summer project in a Japanese logistics company in my hometown (Jakarta) at the end of my first year of study. With my master's degree and my much improved Japanese skills, it didn't take long for me to find work. In fact, right after I graduated, I was accepted at one of Japan's largest trading companies! And the rest is history!

#2 | Global Experience in Japan

My IUJ experience from 2019 to 2021 taught me to know myself better and to use this knowledge to leverage my strengths and grasp my weaknesses, enabling me to improve one step at a time. In IUJ, students are exposed to contrasting cultures and upbringing, sometimes even within their national communities. Such exposure helps one to re-evaluate their thought processes and gain independence. Knowing your values and how you operate is fundamental to confidence building so that, no matter where you go, you can stay true to yourself while adding value to any community.

IUJ's 2-year MBA program offers a comfortable and productive environment to learn to interact with people and listen to others as part of the communication process. The program's group-centric approach lets you simulate real-life corporate discussions especially when diverse groups are involved in a project. Developing strong communication skills can help you in your career as you understand that perfect grammar and language are not the most important factors when conveying a message. You can have the brightest idea in a group, but if you do not know how to share and make the people around you understand your vision, it will be difficult to shine. Engage yourself in open conversations, learn from others, and embrace the chaos different perspectives offer. It is much better and easier to hone your conflict management skills in an academic environment when key performance indicators (KPIs) and corporate targets do not add to the pressure. Furthermore, I have learned while doing my graduation research report that, when multicultural groups (as compared to homogenous groups) first work together, they tend to be inefficient. This is due to members' conflicting management and communication styles. However, when these hurdles are overcome, improved productivity is achieved.

Whether they want to stay in Japan or another country, I believe IUJ students can position the university's multicultural experience to their advantage as more corporate strategies are headed toward diversity and inclusion. For those who see themselves staying in Japan, it is definitely beneficial to study the language as much as you can. Most Japanese companies are still in the early stages of this global change, so it will be less frustrating if you can equip yourself with all the tools on offer to students at IUJ.

IRP trains individuals to become outstanding practitioners and scholars to deal with global challenges

The International Relations Program (IRP) offers two 2-year MA degrees, one in International Relations (IR), and the other in Political Science (PS).

IR students, taking the core courses for the IR degree, acquire the basic concepts and theories of international relations, empirical knowledge, and analytical skills. All of these are necessary to understand the diverse aspects of international relations. PS students take core courses for the PS degree, which cover PS topics such as comparative politics, political institutions, political theory, and methodology, with a strong focus on methodology. PS students thereby acquire sufficient methodological skills to analyze diverse issues in political science.

Additionally, the IRP offers various elective courses. IR degree students can choose courses to focus on particular thematic or regional issues to analyze and understand dynamic, complex contemporary international affairs. Those courses seek to provide more advanced, specific, and up-to-date studies corresponding with the multi-disciplinary nature of the international relations field. PS degree students can choose courses in international relations and international political economy, thereby further broadening their knowledge in political science.

In general, IRP students are expected to develop the capacity to analyze diverse global challenges and propose policy solutions for them, whether from an IR perspective or a PS perspective.

Students develop skills and knowledge for making economic/public policy as professionals

The International Development Program (IDP) offers two 2-year MA degrees: International Development (ID) and Economics (ECO). Students are required to complete coursework (at least 40 credits) and write a thesis or research report using a quantitative approach.

The ID track offers various development-related courses in economics, regional science, and related fields. Throughout their studies, students learn how to evaluate current policies and design more effective ones to encourage economic growth and social development in developing countries. The ECO track emphasizes modern economic theories and their applications. Students learn applied macroeconomics, comprising fiscal policy and international finance, as well as empirical microeconomics including labor, health, and environmental issues to understand and analyze current issues. Both degree tracks aim to equip students with advanced knowledge and skills so that they will tackle and overcome the problems they are facing as new leaders in both the public and private sectors.

The ECO also offers the Macroeconomic-Policy Program (MPP), a special master's program established in cooperation with the IMF (International Monetary Fund). The MPP is designed to provide professionals from central banks, finance ministries, international organizations, and private financial institutions with academic training in the field of macroeconomics.

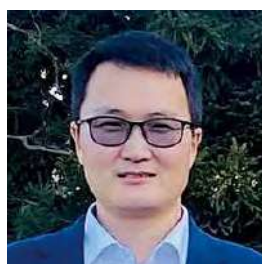

PMPP is designed for future leaders of public and non-profit organizations in the era of globalization and digitalization

The Public Management and Policy Analysis Program (PMPP) offers 2-year master's degrees : MA in Public Management (PM) and MA in Public Policy (PP). Students are required to complete coursework and write either a thesis or research report that can be chosen from a wide range of managerial or policy issues.

The PMPP provides students with the knowledge and skills that are necessary to be good managers in public and non-profit organizations. Basic courses include Introduction to Policy Analysis, Public Policy Process, Statistical Methods, Econometrics, and Microeconomics I. The PM additionally requires Managing Public Organizations, Public Administration, and Public Finance and Budgeting to learn better ways to improve public service delivery, while students in the PP track must take Cost Benefit Analysis, Introduction to Policy Modeling, and Policy Evaluation to understand policy-making and implementation.

A one-year mid-career program designed for future governmental leaders in collaboration with JICA

The International Public Policy Program is a one-year mid-career program, designed for diplomats and government officials of countries in Asia, the Pacific, and around the world. It is a program that has been developed through close consultation between IUJ and the Japan International Cooperation Agency (JICA).

Students in this program will choose their concentration areas (either "International Affairs" or "Public Policy"), depending on their professional backgrounds and career goals, and study various disciplinary-related courses in their respective fields. They will also be able to take a variety of issue-oriented courses as electives, choosing from a wide range of offerings at IUJ. In summer, toward the end of their one-year study program, students will participate in intensive capstone courses, some of which will be delivered by specially invited experts in their field. Students will be given opportunities to discuss global issues, such as the changing international political and economic landscape and global environmental challenges.

Thus, the program will not only encourage students to look back on and systematize their professional experiences, but also enable students to incorporate these experiences into a body of knowledge with which they can further their professional capabilities. The program will also help the students to develop their capabilities to think about and discuss various international public policy issues from long-term, broad, and diverse perspectives.

The PhD Program is dedicated to developing high-level research abilities for a wide range of contemporary international issues through rigorous academic training. It also helps students acquire a long-term vision of a rapidly changing world with diverse perspectives in global contexts. Targeting future leaders in international organizations, public organizations and/or governments, the PhD Program aims at fostering high-level professionals who play an important role in the international arena with theoretical, analytical, and practical abilities as well as advance researchers to be able to operate effectively in an international society. All courses are conducted in English. The PhD program, according to specialized research areas, consists of 3 clusters that are extensions of our 3 existing master's programs in GSIR, i.e., "International Relations Program," "International Development Program", and "Public Management and Policy Analysis Program."

Since its founding as the first US-style business school in Japan, IUJ's MBA program has bridged management thinking between international and Japanese business communities. Lead a global business in the digital society

Advances in digital technologies have drastically changed almost every aspect of our society, including industrial structure, business strategies, jobs, and work styles. Organizations can no longer delay their digital transformations. The digital future is here right now. It is estimated that nearly 40% of all businesses may disappear in the next ten years if they do not accommodate new digital technologies. At the same time, this period provides a rare opportunity for small-to medium-sized companies to narrow the gap with larger competitors.

After nearly 20 years of offering its globally top-ranked e-Business Management Program, GSIM launched a new Digital Transformation Program (DXP) in 2021. It nurtures future leaders who can lead a global business in a digital society by integrating digital technologies and management skills. Instructors in the DXP are faculties familiar with cutting-edge digital technologies, invited industrial practitioners, and guest speakers from across the world. The pedagogy includes case methods, simulations, and team projects. Our graduates gain hands-on experience with new digital technologies (e.g., data science, Big Data, AI, blockchain, AI, cloud computing, cybersecurity, etc.). Learning Universal Logic in Development, grounded in the Japanese experience

The Japan-Global Development Program (JGDP) is a program jointly implemented and managed by the Japan International Cooperation Agency (JICA) and the International University of Japan as part of the JICA Development Studies Program (JICA-DSP). It aims to provide an opportunity to learn universal development and growth logic across the fields of politics, economics, and management, using Japan's experiences in economic development and corporate growth as basic case materials. The JGDP is an international human resource development program introduced by IUJ as the first joint program between GSIR and GSIM. Its outstanding characteristics are:

1. International students learn logic and lessons in development from Japan's experiences (both successes and failures) and acquire knowledge and skills to consider developing strategies for their homelands.
2. Japanese students develop the ability to explain the logic of Japanese development in English by learning about Japan's experiences. With that skill, they are able to communicate their knowledge with the world.
3. Students who will work in the international arena in the future learn the universal logic of economic development and corporate growth using Japan's experiences as case materials.

The JGDP is not intended to be a program that trains Japanese specialists. The logic and lessons from Japan's experiences will help future leaders from abroad as they think about strategies for development back home. Thus, the logic behind Japan's experiences can be applied to various global scenarios. That is why we call this program the Japan-Global Development Program. It enables Japanese students to explain their country's development logically when they go abroad and helps them play an active role as global leaders.

Depending on the students' wishes, they can select an area of concentration from those presented in the following table and choose the school to which they want to belong. As such, those who choose "Foreign Policy", "Economic Policy", "Development Policy", or "Public Management" are part of GSIR, and those who choose "Management" become a member of GSIM.

Curriculum

All JGDP courses emphasize both theoretical background and international comparison.

JGDP courses offered by GSIR cover various fields, from the international political and economic environment after Japan's Meiji Restoration to Japan's education system, the characteristics of Japan's postwar economic growth, Japan's foreign policy, politics, national security policy, and foreign assistance policy.

JGDP courses offered by GSIM provide education on Japanese style management, corporate finance, and Japan's financial system, Japan's major industries, human resource practices, manufacturing management, business leaders, and development of SMEs.

Degree Requirements

The requirements for completing the JGDP are 1) two years of enrollment, 2) acquisition of at least 40 credits, 3) submission of a master's thesis or research report after receiving the necessary research guidance, and 4) passing the thesis/research report evaluation and final examination.

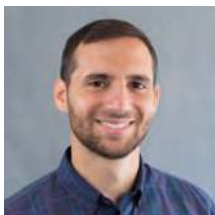

The English language program offers a variety of English language courses throughout the year, even after enrolment, to help students acquire English language skills for their academic and post-graduation career development.

Summer Intensive English Program (IEP)

IUJ's Intensive English Program (IEP) provides intermediate-to advanced-level English training for students who intend to enter IUJ's graduate programs and for professionals who wish to immerse themselves in English in preparation for work assignments that involve substantial international English communication. We offer intensive instruction in developing effective Academic study strategies in an English-only environment and help to prepare students for their course work beginning in the fall term. At the same time, students participate in extracurricular activities for social and cross - cultural communication purposes.

Academic English

IUJ students can take a variety of English - language courses as a part of their graduate studies in IUJ's degree programs. The Academic English courses provide first-year students with the necessary foundation in Academic English to succeed in their graduate studies. Second-year students can take English for Thesis Writing and English for Research Writing courses to prepare for writing their MA thesis or Research Report.

Finally, both first- and second-year students can take the Academic English Literacy course to improve their debate and written argumentation skills.

Business English

The English for Professional Communication courses are offered to IUJ students interested in developing their written (email, memo, and report writing) and spoken (interviewing, meeting management, negotiation) business English skills.

Basic and Elementary Japanese: helps students acquire basic communication skills in Japanese. The Intermediate and Upper-Intermediate course : focuses on mastery of the application of basic Japanese skills. The Advanced course covers the ability to explain and discuss social issues and topics related to learner's interests. An annual Japanese Presentation Exhibition is also held where students can demonstrate their achievements in Japanese language acquisition. The JLP also offers noncredit courses such as Business Japanese, where participants learn honorifics and manners needed for Japanese business situations they are likely to encounter in coming years.

Intensive Japanese Program

Intensive Japanese Programs for zero beginners are held for students sponsored by the International Monetary Fund (IMF) and IUJ students. The programs are 4 to 9 days in length, and help learners acquire what is necessary for their daily lives in Japan such as greetings, self-introductions, phrases for shopping, and phonetic syllables, i.e., *hiragana* and *katakana*.
