## Message from the President

Our International University of Japan, IUJ, is a very unique university. Our uniqueness is the university's biggest asset.

IUJ is the first graduate school-only university in Japan, where, in two professional graduate schools, international relations and international management, multinational faculty members with rich international experiences give specialized education to future global leaders using English as the only language of instruction.

We offer masters programs (and some PhDs) in international relations, international development, public management, business administration and Japanese development. The Japanese Development Program is a new masters program we started in 2018 together with the Japanese International Cooperation Agency (JICA). We think one of our roles, as an English-speaking university located in Japan, is to disseminate knowledge about Japanese logic to the world in English. In this program, students can learn the universal logic of economic development and corporate growth from the wide areas of politics, economy and business, using Japanese experiences as their main case materials. Of course, students in other programs are free to take courses offered in this new program.

Our uniqueness lies not only in our educational programs, but also in our student body and in their daily lives.

Our students come from very diverse countries. More than 80% of our current students (about 350 in total) are foreign students, 80% of which come from about 60 countries in Asia and Africa. Many of them are expected to play leading roles in their homelands. We already have more than 4,300 alumni from more than 120 countries. No other university in Japan can boast such an internationally diversified student body, perhaps no other in the world.

Students' daily life on our campus is also unique. They live in dormitories on our spacious campus in

the middle of the beautiful countryside of Niigata. They both study together and live close to each other for two years, surrounded by beautiful nature. In their daily lives, they learn about other countries and get infinite opportunities for everyday cross-cultural interaction. They also have opportunities to interact with both the nature and history of Niigata. Since it is a prerequisite for a global leader to recognize and respect the value of the histories and cultures of other people, our students can have a continuous training ground for this prerequisite through their daily lives on our campus.

In sum, our university is truly a place, as our students like to put it, "where the world really gathers." This is truly the kind of place which our founder, Sohei Nakayama, a very famous banker who contributed tremendously to build postwar Japan, wanted to create when he founded IUJ in order to educate future global leaders.

We will make every effort to make this asset even greater and more valuable. 

## Distribution of Countries/Regions (Alumni) As of July 1, 2018



# IRP International Relations Program

The International Relations Program (IRP) provides a wide range of study in international relations.

For the MA in International Relations, students learn both the basic theories and concepts of international relations and specialized thematic and regional issues to acquire analytical skills to apply to dynamic and complex contemporary international affairs. Specialized thematic and regional study, of security and peace studies and diplomacy, deals with most updated topics in global affairs, such as civil wars, terrorism, transnational organized crimes, poverty, environmental problems, and sustainable development. Students can also focus on regional studies such as the Asia Pacific region, Japan, China, South Asia, the Middle East, and Eurasia. The program is constructed to allow students maximum freedom to pursue their own interests in the interdisciplinary field of international relations.

IRP students are required to complete a significant amount of reading and to think deeply. Students are expected to be able to provide sharp analysis of the issues they deal with, to engage proactively in discussion, and to propose an effective policy for the solution of the contemporary problems and challenges they deal with.

## Curriculum

The International Relations Program (IRP) begins with training in the foundation of international relations. Students must choose at least five basic courses (out of nine) to consolidate this basic understanding. Those courses seek to provide students with the conceptual foundations, empirical knowledge, and analytical skills that are required to understand all aspects of international relations.

The IRP also offers twenty-nine core elective courses with thematic and regional foci. Those courses seek to provide more advanced, specified, and up-to-date studies corresponding with the dynamic and multi-disciplinary nature of the international relations field. The thematic courses deal with the current issues of human security, refugees, environment, conflict resolution and peace building, the United Nations, global civil society. The regional courses include regional studies of Japan, China, the United States, Southeast Asia, the Middle East, and Eurasia. Such diverse course offerings allow considerable flexibility for students to customize their academic pursuits in the course of their two-year master's study.

Besides the IRP courses listed above, students need to take courses in three basic discipline areas: "Political Science" and "Economics in the GSIR, and "Management" in the GSIM. Students are required to obtain at least two credits from each area and obtain at least eight credits in total from the three basic discipline areas.

## Degree Requirements

The requirements for completing the IRP are 1) two years of enrollment, 2) acquisition of at least 40 credits, 3) submission of a master's thesis or research report after receiving the necessary research guidance, and 4) passing the thesis/research report evaluation and final examination. A credit requirement breakdown for each course category is shown below.

Students are awarded M.A. in International Relations at the time of completion.

# IDP

## International Development Program

In the International Development Program (IDP) students choose one of two Master's degree tracks:

International Development (ID-IDP) or Economics (ECO-IDP).

The International Development (ID-IDP) track offers various development-related courses in economics, regional science, and related fields, while the Economics (ECO-IDP) track puts strong emphasis on modern economic theories and their applications.

The ECO-IDP also offers a special Macroeconomic-Policy Program (MPP) master's program. The MPP is especially designed to provide professionals from central banks, finance ministries, international organizations, and private financial institutions involved with the IMF with rigorous academic training in the fields of macroeconomics.

### Curriculum

To complete these degrees, students take both required and elective coursework and write and defend a thesis or research report.

Both degree tracks start with a series of challenging courses in statistics, and micro/macroeconomics in the Fall and Winter Terms. The ID-IDP then emphasizes econometrics and development economics before moving the students toward their preferred areas of emphasis.

The ECO-IDP, after the initial pre-requisite courses, turns to areas such as

Public Finance, Monetary Economics and Policy Analysis, International Finance, etc. Beginning in the Spring of their first year, and continuing through their second year of study, students in both degree tracks can choose from a wide range of electives. They are encouraged to take courses not only from the IDP, but also the IRP, PMPP, JDP and MBA as well.

Besides the IDP courses listed above, students need to take courses in three basic discipline areas: "Political Science" and "Economics" in the GSIR, and "Management" in the GSIM. Students are required to obtain at least two credits from each area and obtain at least eight credits in total from the three basic discipline areas.

### Degree Requirements

The requirements for completing the IDP are 1) two years of enrollment, 2) acquisition of at least 40 credits, 3) submission of a master's thesis or research report after receiving the necessary research guidance, and 4) passing the thesis/research report evaluation and final examination. A credit requirement breakdown for each course category is shown below.

Students who complete all requirements are awarded a Master of Arts in International Development or a Master of Arts in Economics.

# PMPP

## Public Management and Policy Analysis Program

The Public Management and Policy Analysis Program (PMPP) aims to meet the need for "good governance" in the public sector, which is required to implement and evaluate policies covering diverse public problems. The PMPP trains public managers in issues such as environmental protection, public health, e-governance, education, national and regional development, welfare reform, and international security. We strongly believe that gaining knowledge from the PMPP can be the best solution for working professionals in various public sectors like state and local governments, international institutions, NGOs, and public enterprises.

### Curriculum

The PMPP's two-year curriculum consists of a combination of core required, core elective, and elective courses.

To earn the program's Master of Arts in Public Management degree, students are also required to complete a thesis or research report under the supervision of GSIR faculty member.

Core required courses provide students with disciplinary and analytical knowledge and skills such as public management and administration, economics, public finance, accounting, law, and statistics, which give them an understanding of all aspects of public management and policy analysis and allow them apply that knowledge to real world

issues in the public sector. Core elective courses focus more on the specific aspects of public policy, like environmental issues, health care systems, regional development, and e-governance. Practical and policy-oriented elective courses expand students' theoretical capability and descriptive knowledge developed in required courses in order to hone their problem-identification and problem solving skills in regional and international agendas.

Besides the PMPP courses mentioned above, students need to take courses in three basic discipline areas: "Political Science" and "Economics" in the GSIR, and "Management" in the GSIM. Students are required to obtain at least two credits from each area and obtain at least eight credits in total from the three basic discipline areas.

### Degree Requirements

The requirements for completing the PMPP are 1) two years of enrollment, 2) acquisition of at least 40 credits, 3) submission of a master's thesis or research report after receiving the necessary research guidance, and 4) passing the thesis/research report evaluation and final examination. A credit requirement breakdown for each course category is shown below.

Students are awarded a Master of Arts in Public Management at the time of completion.

# JDP

## Japanese Development Program

The Japanese Development Program (JDP) is a two-year master's program newly established by IUJ to provide students the opportunity to learn universal development and growth logic in the fields of politics, economy and management, using Japan's experiences in economic development and corporate growth as basic case materials. The JDP is built on the following characteristics:

1. International students learn about the logic and lessons (both successes and failures) from experience behind Japan's economic development and acquire knowledge and skills to consider economic development strategies for their homelands.
2. Japanese students develop the ability to explain Japanese logic in English by learning Japan's history, culture, logic and lessons of economic development and thus can send messages about Japan to the world.
3. Students who will work in the international arena in the future learn about the universal logic of economic development and corporate growth by using the Japanese experiences as a case material.

JDP is the first master's program offered jointly by the Graduate School of International Relations (GSIR) and Graduate School of International Management (GSIM) for global leadership development. Since admission screening is conducted by each school, JDP applicants apply to either school based on their own specialties.

### Curriculum

JDP courses offered by GSIR (JDP-IR) provide education on the international political and economic environment after Japan's Meiji Restoration and the characteristics of postwar Japanese economic growth. In addition, the courses teach how Japan's foreign policy, national security policy, foreign assistance policy, public finance and administration, and the educational system affected Japan's development.

JDP courses offered by GSIM (JDP-IM) provide education on the impacts of Japan's industrial development and the innovation behind it after the Meiji Restoration, Japanese style management, corporate finance and financial systems, employment practices, manufacturing management, business leaders and how development of SMEs have affected, Japanese economic development.

All these JDP courses emphasize theoretical background and international comparisons.

Besides the JDP courses listed above, students need to take courses in three basic discipline areas, "Political Science" and "Economics" in the GSIR, and "Management" in the GSIM. Students are required to obtain at least two credits from each area and obtain at least eight credits in total from the three basic discipline areas. In addition, students must take all the required courses designated by the school to which they belong.

#### Degree Requirements

The requirements for completing the JDP are 1) two years of enrollment, 2) acquisition of at least 40 credits, 3) submission of a master's thesis or research report after receiving the necessary research guidance, and 4) passing the thesis/research report evaluation and final examination. A credit requirement breakdown for each course category is shown on the next page.

Students belonging to GSIR are awarded an MA in International Development, and students belonging to GSIM are awarded an MBA at the time of completion.

#### JICA Development Studies Program (JICA-DSP)

The JDP is a program jointly developed by the Japan International Cooperation Agency (JICA) and the International University of Japan.

IUJ's MBA Program was started in 1988 as the first US-style business school in Japan, offering all courses in English. It acquired certification in 2018 as an educational institution offering the highest standards of business education in the world from AACSB (The Association to Advance Collegiate Schools of Business) International, an organization that evaluates management education. It has been recognized many times as one of the top 100 global MBAs by the Economist's "Best Business Schools" ranking, the only MBA in Japan to make this list. These facts guarantee the educational quality of the program. The IUJ MBA challenges the current generation to become socially responsible world business leaders. Our program, which focuses on "Leveraging Emerging markets (such as Asia and Africa) for Global Advantage" delivers the knowledge, skills and mindset required to take best advantage of the world's fastest-growing economies for global competitive advantage.

## Curriculum

In the first year of the MBA Program, students tackle the essentials of management with an emphasis on global leadership and emerging markets through case studies in their core courses. Case studies are used in most classes, and cases on issues in Asia, Africa, and Latin America are regularly included. Group work is emphasized, and each group is made up of people from diverse cultures to encourage cross-border communication and global team leadership skills. The educational environment of this program, which consists of a multi-national student body from about 40 countries, is extremely unique.

From the Spring term and into the second year, MBA students should begin to specialize in their IUJ education in line with the career they seek after graduation. Specializations include Finance, Marketing, Management, and IT/OM/SCM/PM/SE. \* Seeking a double specialization is possible for the most ambitious. In addition to their chosen specialization, the students can take elective courses as shown in the table on the right. Those who prefer to take courses from various specialized areas do not need to choose a specialized area.

Besides MBA courses, students need to take courses in three basic discipline areas, Political Science and Economics taught in the GSIR, and Management taught in the GSIM. Students are required to obtain at least two credits from each area and obtain at least eight credits in total from these three basic discipline areas.

Students seeking employment in Japan or as a bridge between their home countries and Japan are highly encouraged to take advantage of the strong Japanese language program offered by our dedicated faculty.

## Degree Requirements

The requirements for completing the MBA are 1) two years of enrollment, 2) acquisition of at least 40 credits, 3) submission of a master's thesis or research report after receiving the necessary research guidance, and 4) passing the thesis/research report evaluation and final examination. A credit requirement breakdown for each course category is shown in the table on the right.

Students are awarded an MBA at the time of completion.

With the rapid rise of emerging mega-markets and the increasingly integrated global economy, global competition today is undergoing a profound shift. Corporations must proactively initiate changes to create competitive advantage over their rivals. Such initiatives are cross-functionally integrative in nature as disconnected functional moves rarely lead to competitive advantage. Thus, today's global competition requires a critical pool of global managers who can work across boundaries of business functions and mobilize their business as an integrated whole. The IMBA program aims to train global management human resources.

The E-Business Management Program IUJ has been offering will be merged into the IMBA in 2019 as an **E-business (E-biz) concentration** to develop human resources who can play an active part in a variety of business settings with the insight of general management and the knowledge to utilize IT efficiently and effectively.

### Curriculum

The IMBA program is designed only for the most capable and best motivated individuals who are willing to go back to graduate school for an intensive 12-month period to turbo-charge their careers to the next level. The curriculum is compact, rigorous, and demanding. During the time they spend on the IUJ campus, students tackle the essentials of management with an emphasis on global leadership and emerging markets. Case studies are used in most classes. These cases focus on issues in not only advanced countries but also emerging countries in Asia, Africa, and Latin America. Group work is emphasized and each group includes people from diverse cultures to encourage cross-border communication and global team leadership skills.

### Summer Capstone Courses

Capstone courses are the final wrap-up for the IMBA program. Taken in the summer months prior to graduation, they integrate elements from multiple courses already completed to address timely managerial issues and challenges of competitive importance. Capstone courses consist of three one-credit required courses; "International Career Development," "Leadership Bootcamp," and "Strategy Simulation," which all reflect emerging issues of global competition.

### Degree Requirements

The requirements for completing the IMBA are 1) one year of enrollment, 2) acquisition of at least 32 credits, 3) submission of a master's thesis or research report after receiving the necessary research guidance, and 4) passing the thesis/research report evaluation and final examination. A credit requirement breakdown for each course category is shown in the table on the right.

Students are awarded an MBA at the time of completion.







※ IMBA students can participate in exchange programs during the fall term after completing all the degree requirements. In that case, graduation from IUJ is deferred to Dec. 31, and an additional tuition fee for the fall term will be charged.



# PhD Program

In response to strong needs for higher level professionals in an increasingly globalized society, GSIR launched a PhD Program in September 2015.

Targeting future leaders in international organizations, public organizations and/or governments, the PhD Program aims at fostering high level professionals playing an important role in international arena with theoretical, analytical, and practical abilities as well as fostering researchers to operate effectively in international society.

The PhD program, according to specialized research areas, consists of 3 clusters that are extensions of our 3 existing Master's programs in GSIR, i.e., "International Development Program," "Public Management and Policy Analysis Program" and "International Relations Program."

- **Economics Cluster (Degree: PhD in Economics)**
- **Public Management Cluster (Degree: PhD in Public Management)**
- **International Relations Cluster (Degree: PhD in International Relations)**

The PhD Program is dedicated to developing high-level research abilities for a wide range of contemporary international issues through rigorous academic training. It also helps students acquire a long-term vision of a rapidly changing world with diverse perspectives in global contexts. All courses are conducted in English.

- **Economics Cluster**

fosters researchers with the specialized knowledge and high-level research ability in Economics including quantitative and statistical methods, and fosters those professionals with the above-mentioned knowledge and abilities which can be applied to relevant jobs (such as economic development or economic policy formulation) in such places as international organizations and government bodies.

- **Public Management Cluster**

fosters researchers with the specialized knowledge and high-level research ability in Public Management, and fosters those professionals with the above-mentioned knowledge and abilities which can be applied to relevant jobs (such as effective management) in such places as international organizations and government bodies

- **International Relations Cluster**

fosters researchers with the specialized knowledge and high-level research ability in the increasingly complex field of International Relations, including security, and fosters those professionals with the above-mentioned knowledge and abilities which can be applied to relevant jobs (such as

security policy formulation) and be implemented in such places as international organizations and government bodies.

## Degree Requirements

PhD candidates must satisfy the following requirements while enrolled in the program for a minimum of 3 years and receiving necessary research guidance.

Ⓞ To obtain 8 credits (4 courses) from the "Common Elective Required Courses" (listed below) including 6 credits (3 courses) from the required courses for their chosen Cluster.

- **Economics Cluster**

Advanced Microeconomics, Advanced Macroeconomics, Advanced Econometrics I

In addition, students are strongly urged to take Advanced Econometrics II.

- **Public Management Cluster**

Ⓞ To obtain 9 credits from "PhD Dissertation Advanced Seminar I, II and III" (which carry 3 credits each).

Ⓞ To pass the PhD candidate examination conducted at the end of 1st year. Candidates will be given a second chance during the 2nd year to take this examination if they fail the examination in the 1st year.

Ⓞ To pass the evaluation and the final examination of their PhD dissertation. The PhD dissertation is, in principle, comprised of three academic papers, one of which must be accepted by a refereed academic journal.

## Curriculum and Courses

The PhD curriculum consists of Common Elective Required Courses and PhD Dissertation Advanced Seminars. The Common Elective Required Courses are designed to give students high level specialized and scholastic knowledge and research capability required for PhD candidates. The PhD Dissertation Advanced Seminars are designed to give students guidance for writing a PhD dissertation.

## English Language Program (ELP)

English is the official language at IUJ. Those needing extra support are encouraged to take our 8-week Intensive English Program (IEP) in the summer before they become full-time students. In addition, throughout the academic year English and academic writing courses are offered to equip students with the language and skills they will need for their academic and professional careers.

### Academic English

IUJ students can take a variety of English-language courses as a part of their graduate studies in IUJ's degree programs. The Academic English courses provide first-year students with the necessary foundation in academic writing to succeed in their graduate studies. Second-year students can take English for Thesis Writing courses to prepare for writing their MA thesis.

### Summer Intensive English Program (IEP)

IUJ's Intensive English Program (IEP) provides intermediate- to advanced-level English training for students who intend to enter IUJ's graduate programs and for professional people who wish to immerse themselves in English in preparation for work assignments that involve substantial international English communication.

We offer intensive instruction in developing effective academic study strategies in an English-only environment and help to prepare students for their course work beginning in the fall. At the same time, students participate in extracurricular activities for social and cross-cultural communication purposes. Students also learn how to use the university's facilities to access e-mail and the Internet.

This is an eight-week program that runs from mid-July to mid-September.

## Japanese Language Program (JLP)

Basic and Elementary Japanese: helps students acquire basic communication skills in Japanese. Intermediate: focuses on Mastery of the application of basic Japanese skills. Advanced: covers the ability to explain and discuss social issues and topics related to learner's interests. A Japanese Presentation Exhibition is held annually where students can demonstrate their achievements in Japanese language acquisition. The JLP also offers noncredit courses such as Business Japanese, where participants learn honorifics and manners needed for Japanese business situations.

Intensive Japanese Programs for zero beginners are held for students sponsored by the International Monetary Fund (IMF) and IUJ students. The programs are 4 to 6 days in length, and help learners acquire what's necessary for their daily lives in Japan such as greetings, self-introductions, phrases for shopping, and phonetic syllables, i.e., hiragana and katakana

### 1 Main Buildings

Classrooms, study rooms (open 24 hours), faculty and admin. offices, meeting rooms, etc.

### 2 Matsushita Library and Information Center (MLIC) 1F: Office, PC Rooms 2F: Library 3F: Hall

The MLIC was built in 1988 with donations from Panasonic Corporation, formerly known as Matsushita Electric Industrial Co., Ltd.. The library holds about 100,000 books (80% foreign), 11,000 electronic books, 73,000 electronic journals and 17 online databases. It is open until 0AM during the semester. PC rooms are available for 24 hours a day.

### 3 IUJ Research Institute 1F: Lounge 2F: Seminar room 3F: Faculty offices 4F: Accommodation for guests

The IUJ research institute has conducted research projects on global problems and issues facing Japan and the entire world in order to make proposals and recommendations to contribute to solving such programs.

### 1 Cafeteria (1F) & Snack Lounge (2F)

The cafeteria is open for lunch, café and diner. Daily menus including Halal food are served. Snack Lounge is open 24 hours and is used for students' study, group works and parties.

### 2 School Shop

The school shop offers drinks, snacks, bread, cleaning supplies, school supplies, dry cleaning service, postal services, business card printing services and parcel delivery services. It is open Monday through Friday 8AM – 7PM and Saturday and Sunday 1PM – 7PM.

### 3 Energy Center

The Energy Center is responsible for monitoring all equipment and facilities to ensure their safe and consistent operations. This entails monitoring machines and indicators in person 24 hours a day.

### 4 Gymnasium (1F) & Training Room(2F) 5 Four Tennis Courts 6 Barbeque Site

A full-sized gymnasium and work-out room are open from morning till midnight. There is a shower room in the building, too. Two tennis courts offer lightning system and are available till 10PM. IUJ also offers a barbeque site for leisure. The large campus, situated in natural surroundings and beautiful mountain scenery is good for jogging and walking, too. During the winter season, IUJ's location in the heart of Japan's Snow Country makes for a cross-country and down-hill skiing paradise.

IUJ boasts 300 private rooms for all our single students, with private baths, a bed, bedding, LAN connection and WiFi. Each dormitory has a public kitchen, laundromat and lounge. There is an apartment building with 18 units, each with a private kitchen and bath, for married students on campus, too. At least one English-speaking dormitory staff member is stationed in the dormitories 24 hours a day. IUJ supplies more private dorm units with kitchenettes and a refrigerator in apartment buildings about 1.5 – 2 Km from campus for your second year (single students).

Through dormitory life with different nationalities and different backgrounds, you can learn from each others' world views and gain awareness of critical issues while learning to work together. A borderless and independent environment is created in the dorms as a result of allocating rooms without regard to students' nationalities and gender.

### 5 Faculty Residences

### 1 SAKURA (Cherry Tree) Lane

When the Sakura trees bloom in April, this Sakura Lane turns beautiful pink. Students like to sit under the trees and enjoy "Ohanami" (viewing cherry blossoms).

### 2 Alumni Forest

Each year, two new trees are added to the Alumni Forest, one for the International Relations graduating class, and one for the International Management graduating class.

### 3 Natural Park

Nature abounds on and around the IUJ campus. If you need a break from studying, there's plenty of fresh air to enjoy nearby.
